1. The construction work of the G+ 4 storied school bldg (as per requirement of the user dept) with height of 19.20 mts. has been completed as per the drawings approved by the B.P Dept. u/no. Dy. Ch.E/BP/2150 dtd. 22.05.2014 and CFO NOC u/no. FB/LR/RV/72 dtd.02.01.2014
2. The work of the school bldg. u/r has been completed and the structural stability certificate has also been received by this office from E.E. (E.S.)SIC.
3. Final NOC from CFO department for the completed work has been obtained u/no. FB/LR/R-V/15 dtd. 01.11.2019.

As all the compliances required by the B.P.Dept. are complied with and the school bldg. is constructed as per the B.P. approved plans, this office hereby convey its concurrence for the occupation of the Aziz Baugh Municipal School from architectural planning and circulation point of view.

Education Officer has taken approval from Hon'ble M.C vide u/no. MDG/3408 dt 24.1.2020 regarding the provision of substation in the said municipal school plot and

same is under process by User Department. It is to mentioned here that, the appointed Contractor M/s Tirupathi Construction Corporation has given the undertaking stating that he will not disconnect the temporary meter on site for the further period of 6 months or till the permanent meter is installed on site. Whichever is earlier.
